

CONTINUOUS CORN MANAGEMENT

- Good choice for fields with a history of Goss' wilt.

PLACEMENT / MANAGEMENT

Go anywhere hybrid. A good fit across soil types. Late harvest option. Full-flex ear adapts to a wide range of planting rates.
